For International Trade – FOB, CIF by Air, CIF by Sea							
1. Payment Terms							
All orders are strictly accepted against 100% Advance Payment upon submission of a Valid Purchase Order (PO) and a Mutually Signed Agreement .							
Payment shall be made via Bank Wire Transfer (SWIFT/TT) or other approved international remittance channels.							
2. Delivery Timeline							
Estimated delivery timelines will be confirmed only upon receipt of the PO and Advance Payment .							
Delivery schedules are subject to market conditions, shipping availability, customs clearance, and regulatory compliance .							
3. Tariff Modes							
FOB (Free On Board – Indian Port):							
Our responsibility ends once goods are loaded onto the vessel at the designated Indian port.							
All further liabilities including freight, insurance, duties, and destination charges lie with the buyer.							
CIF by Air/Sea (Cost, Insurance, and Freight):							
Freight and insurance are included up to the agreed destination port/airport.							
Buyer is responsible for all duties, taxes, customs clearance, and documentation at the destination country.							
4. Duties, Taxes & Import Documentation							
All import duties, taxes, destination port/airport handling charges, and final clearance documentation are the sole responsibility of the Consignee/Buyer.							
Any delay or cost arising from customs clearance at the destination shall be borne by the buyer.							
5. Insurance							
For CIF terms, basic marine/air cargo insurance is included as per international trade norms.							
Any additional insurance requirements must be communicated in advance and will be chargeable.							
6. Product Specifications & Compliance							
Products will be shipped strictly as per specifications and quality mentioned in the invoice and agreement.							
Buyer is advised to confirm local regulatory compliance and product admissibility prior to finalizing the order.							
7. Packaging & Labelling							
Packaging will be standard export-worthy unless otherwise specified and mutually agreed.							
Buyer-specific branding/labeling requirements must be shared in writing with approved artwork before dispatch.							
8. Delay or Non-Delivery Due to Force Majeure
